
### **ABOUT ADITUM**

## ADITUM ALTERNATIVE INCOME FUND COMMENTARY

US stocks fell in December as investors pared back bets on the number of Fed rate cuts expected in 2025 following a series of data points that showed continued strength in the underlying U.S. economy. November inflation rose by 0.3%, with annual CPI reaching 2.7%, up from 2.6% in October. Overall, the labour market stayed resilient with nonfarm payrolls coming in slightly above consensus (220K) at 227K. In fixed income, the 10-year US bond yields continued to rise throughout the month peaking at 4.63% before ending at 4.57%. Energy prices fluctuated throughout the month but continued to remain rangebound with Brent crude closing at ~\$75.

In December, central banks chose different actions regarding their policy rates. In the U.S., the Fed cut the federal funds rate again by 25 basis points to 4.25%-4.50% but refrained from providing clear guidance on further rate cuts in 2025. The ECB, like the Fed, lowered its deposit facility rate by 25 basis points to 3.5%. The Bank of England and the Bank of Japan kept their policy rates unchanged at 4.75% and 0.25%, respectively. The US dollar continued to rally with continued expectations of inflationary Trump fiscal plans and a shorter Fed rate-cutting cycle. Heading into 2025, all eyes remain on the President-elect Trump, who is set to take office on January 20<sup>th</sup>, and what policies his administration may bring.

In terms of fund performance, the Fund contracted 0.52% for the month. The top performers for the Fund were Four Quadrant Dynamic Allocation Fund and Man Dynamic Income Fund. We continue to favour long/short credit strategies and investment grade private credit strategies with locked-in yields while also seeking attractive opportunities to enhance our expected yields.


